



The Assembly is the voting membership of the OIAA and is made up of representatives (IGR) of Groups that list their meetings in the OIAA. searchable database of online meetings*, as well as Standing Committee Chairs and OIAA Officers.

*Your meeting des not have to be listed for your IGR to serve.





Non-Voting Members – all of the resources of the OIAA without the right to vote at the General Assembly meetings.



 Steppers – when anyone, anywhere reaches out for help via the "Get Help Now" button shared with any online entity the requests it or submits an online form on the OIAA web site, an average of 3+ Steppers respond via email. The OIAA has Steppers who having been doing this 12 Step work for many years, coach and train new Steppers, and can respond in a number of languages.




 Public Information Committee (PIC) – when anyone, anywhere submits questions via an online form on the OIAA web site, a team of volunteers respond, usually the same day.
